The letter will provide reason(s) as to why the claim(s) have been rejected and allow the opportunity to resubmit within the established timeframe. To be eligible for the rebate, the purchase must be made from the following approved parts: Ford New or Remanufactured Gas Engine Assembly, Ford New or Remanufactured Transmission Assembly, or any of the following Motorcraft® parts: Alternator, Battery, Brake Drums OR Rotors, Brake Pads OR Shoes, Fuel Delivery Module, Gasoline Engine Oil Filters OR Gasoline Engine Air Filters OR Gasoline Fuel Filters, Gasoline Intake Manifold, Ignition Coil, Starter or Windshield Wipers. The purchase must take place between 1/01/16 and 4/30/16 (the "Rebate Program Period") to be eligible for the rebate. Purchase invoice and completed rebate form are required. Rebate form must be submitted by IRF. Purchase invoice date and sale date must fall within Rebate Program Period. Rebate form must be completed in full, legible and submitted online or postmarked by May 31, 2016 along with supporting documentation. Product must be purchased from a Ford of Canada Dealership. Non-Ford automotive OE Dealerships are eligible if they do not share ownership (private, public, whole, part) with a Ford or Ford Lincoln Dealership. Open to legal residents of Canada only. All Ford and Ford Lincoln Dealers and employees are ineligible. Handwritten purchase invoices will not be accepted. Retain a copy of rebate form and original invoice for your records in the event backup documentation is requested. Rebate cheque will be issued 6 to 8 weeks from receipt and validation of rebate and proof of purchase. Cheque will be payable to the business name.
